

#### 2022 NCP Program Highlights


- Exam window: April 16-May 7
- 276 Registered to take the 2022 NCP Exam
  - 54 no exam activities (including 5 no show) possibly side effects of RTO or COVID
  - 52 transferred to 2023 NCP Exam
- 170 took NCP Exam (119 at testing centers; 51 tested via OnVue)
  - National passing rate = 52%
- Today we celebrate 89 new NCPs!
- Cumulative # of NCPs 2011-2022:
  - Nearly 1,150 examinees have earned their accreditation past 12 years
  - Currently, 908 active NCP's


#### **NCP Examinees Historical Data**



#### NCP Accreditation Growth




#### # Examinees by Administration Year













#### STUDY TIME BY TESTING MODE

#### National NCP Forum

- National NCP Forum is a group of active NCPs from across all organizations who network to discuss industry issues and share solutions to everyday check payment industry problems
  - Content driven by the NCP community
  - Exclusive for NCPs
- Virtual meetings: ECCHO facilitates discussion and provides guidance when necessary
- Discussion driven by audience (member) participation
  - Sessions will be for 60 mins (ECCHO reserves the right to end the session for lack of participation)
  - Eligible for 1.2 CE credits (you must attend all 60 mins to get credit)

#### NCP Continuing Education (CE)

- As an NCP, it is important to maintain your credential through continuing education (CE) credits
  - In the year the certification is earned, you are provided additional time (over the 5 years) between
     April 1 and Dec 31 to maintain the accreditation
  - CE credits are filed/process between Jan 1 and Mar 31 annually for prior year's earnings via <u>ECCHO</u>
     Online.
    - CE sessions can be entered throughout the year; however, they are held in a "pending status" until filing/process fee is paid
  - Certification 5-year renewal cycle requirements include:
    - 50 credits of approved Continuing Education
    - 3 ECCHO hosted NCP Workshops
- Maximums per calendar year
  - 30 CE credits plus 2 NCP Workshops within a given year
- For credit filing process outline: <u>CE credit filing</u>
- For guidance on how to earn CE credits: CE Program Guidance link










# **CONFLICT**


Problem solving and conflict resolution




# **5 ASPECTS OF PERSPECTIVE TAKING**

Everyone involved has a unique perspective

Person's perspective selects and organizes what the person attends to and experiences






### **5 ASPECTS OF PERSPECTIVE TAKING**

➤ People have different perspectives at different times.

The same message can mean two entirely different things from two different perspectives



#### **5 ASPECTS OF PERSPECTIVE TAKING**

Misunderstandings often occur because we assume that everyone sees things from the same perspective as we do

### **Putting Things Into Perspective**

Even in the short term, a positively uncomfortable experience can help us brainstorm, see old problems in a new light, and tackle the challenges we face with new energy.

#### **5 Steps to Putting Things in Perspective**

- Ask yourself what are the costs to you and other people around you when you react with such intensity.
- Stand back and observe and describe –don't judge.
- > What can you still do even if this is true?

### **5 Steps to Putting Things in Perspective**

How will you feel a out this in a week, month or year?

> Think about the event as an inconvenience

See things from other people's point of view


Does it matter what other people think?

➤ Ask a Third Party for their Views






Be willing to think you may be WRONG
